



**MEMORANDUM OF UNDERSTANDING
BETWEEN

NUML and MPL, hereinafter will be referred as “Parties”, have agreed as follows:

**Article 1
General Principle**

The Parties shall implement the provisions of this MOU in conformity with their organizational and relevant country laws and other obligations and will promote cooperation in the fields of academics, research and commercialization in a structured fashion by developing and carrying out collaborative activities.




Article 2
Areas of Cooperation

The main areas of mutual cooperation between the Parties within the limits of their responsibility shall be as follows: -

- a. Discounted rates on clinical laboratory and patient consultancy services (Annexure A)
- b. Special discounted rates on Laboratory services across Pakistan.
- c. Free delivery of medicines and Lab Test home sampling all across Pakistan.
- d. Special discount on Home Physiotherapy, Home Nursing care, Doctor at home, and Vaccination Services.
- e. Tele Consultation Unlimited calls for 01 year in Just Rs.999/-.
- f. Insurance/Hospitalization Starting from Rs.999/-.
- g. Second Opinion from US Consultants Starting form Rs.6,999/-.
- h. Symptom based doctor identification.
- i. Specialized unit for women healthcare including lowest breast cancer test (BRCA).
- j. Internship and job placement opportunities for Students.
- k. Joint educational and research activities in healthcare sector.
- l. Joint seminars, lectures, conferences, workshops, and symposia.
- m. Cash and credit facility for university.
- n. Other activities such as deemed appropriate by mutual consent.

Article 3
Legal Liabilities

It is understood that neither party to this MOU is the agent of the other and neither is liable for the wrongful acts or negligence of the other and this will involve no financial/legal liabilities on any party even if it is amended or modified or reviewed at any time through mutual consent of both parties in writing. Standard policies of NUML and MPL shall be applied for all mutual working relationships.

Article 4
Amendment or Modification

This MOU may be amended or modified at any time through mutual written consent of the Parties. The amendment or modification shall enter into force in the like manner as provided in Article 7 of this MOU.

Article 5
Settlement of Disputes

All differences or disputes arising from or concerning with the application, or the interpretation of this MOU shall be amicably settled through mutual consultations and negotiations between the Parties in writing.

Article 6
Non-Financial Obligating Document

This MOU is neither a fiscal nor a financial obligation document. Any endeavor or transfer of anything of value involving reimbursement or contribution of funds between the parties to this MOU will be handled in accordance with applicable laws, regulations, and procedures of the parties. Such endeavors will be outlined in separate document that shall be made in writing by representatives of the parties and shall be independently authorized by appropriate statutory authority. This MOU does not provide such authority.

Article 7
Entry into Force, Duration and Termination

This MOU shall enter into force on the date of Signatures and shall remain enforced unless terminated by any party. Either party may terminate this MOU by giving a notice of its intention to terminate this MOU six months before the expiration of the original or the renewed period. This MOU can be extended with mutual consent of the parties for an agreed upon duration. The activities undertaken during the validity of this MOU shall continue to be governed by its provision till their completion unless the Parties agree otherwise.
