- 4. In the first instance technical proposal shall be opened and evaluated **as per criteria** given in bidding documents.
- 5. After the technical evaluation, financial bids of only technically responsive bidders will be opened.

- 7. The bidders shall submit bid for complete scope of work as specified in bidding documents. Incomplete bids or bids covering partial scope of work will be rejected.
- 8. All bids must be accompanied by a bid security in the shape of irrevocable bank guarantee or CDR in favour of NUML of the amount specified in the bidding documents issued by NUML.
- 9. The acceptance / rejection of bids shall be governed by Public Procurement Rule 2004.
