- Bidding will be carried out by adopting “**Single Stage Two Envelope (SSTE)**” procedure as per Public Procurement Rule-2004
- The bid shall be a single package consisting of two separate envelopes, containing separately the financial and technical bid.
- The envelopes shall be marked as “**Technical proposal**” and “**Financial Proposal**”
- In the first instance technical proposal shall be opened and evaluated **as per criteria** given in bidding documents.
- After the technical evaluation, financial bids of only technically responsive bidders will be opened.
- Pre-bid meeting will be held on **30 May 2023 at 11:00 hours** at **Director Technical Office of main campus – NUML.**
- The bidders shall submit bid for complete scope of work as specified in bidding documents. Incomplete bids or bids covering partial scope of work will be rejected.
- All bids must be accompanied by a bid security in the shape of irrevocable bank guarantee or CDR in favour of NUML of the amount specified in the bidding documents issued by NUML.
- The acceptance / rejection of bids shall be governed by Public Procurement Rule 2004.
- Bidding documents can be obtained from office of undersigned on payment of Rs.10,000/- (Rupees ten thousand only) (Non-refundable) to be deposited in the university finance branch. Technical Proposal shall contain along with following documents :-
