- 11. Proof of valid / updated / renewed registration with PEC (Pakistan Engineering Council) / Pakistan Council of Architects Town Planning (PCATP) as practicing consultants renewed upto 30 June 2023 or beyond.
- 12. Performance Certificate from the various clients of past/current projects.
- 13. Summary of proposed key staff working with firm for the last 12 twelve months to be supported with required documents as per pre-qualification documents.
- 14. Request on company letter head to obtain prequalification document.
- 15. An affidavit on judicial stamp paper of Rs. 100/- to the effect that the firm/company has never been involved in litigation/arbitration, nor it has been black listed due to any reason, any other relevant information.
- 16. Details of requirement & particular given in the pre-qualification documents can be obtained from the office of undersigned during working hours by providing their above mentioned details (except on saturday and sunday) for a cost of Rs 5,000/- (non-refundable).
- 17. Applications / profiles complete as per-prequalification documents in all sealed envelope must reach the University by 1100 hours on 5 June 2023, which will be opened at 1130 hours and will scrutinize / evaluate by the technical supervisory committee. The competent authority can reject single or all tender under PPRA 2014 rule #33 (1). However, upon their request necessary details shall be communicated to any consultant who has submitted a bid.
